# Overview

The Canadian super visa is designed for foreign nationals, **parents, and grandparents** who wish to visit Canada for tourism, sightseeing, visiting friends and family, attending a conference, or engaging in other related activities.

The Super Visa allows parents and grandparents of Canadian citizens and permanent residents to come to Canada as visitors for up to five consecutive years (effective July 4, 2022) on their initial visit without having to renew their status and the **super visa can remain valid for up to 10 years.**

# Benefits

**The Super Visa is available year-round and has minimum income requirements.** The Super Visa is ideal for parents and grandparents living in countries that require a Temporary Resident Visa (TRV) which includes Pakistan for entry to Canada.

By obtaining the Super Visa, they will be able to travel freely between Canada and their country of residence without the worry and hassle of regularly re-applying for a TRV.

# Eligibility Criteria:

The applicant should be able to meet following requirements:

- Be the parent or grandparent of a Canadian citizen or a permanent resident of Canada
- Have a signed letter from your child or grandchild who invites you to Canada that includes:
  1. a promise of financial support for the length of your visit
  2. the list and number of people in the household
- Proof of medical insurance coverage for at least one year with a Canadian insurance company
- The child or grandchild who invites you must prove that their household meets the minimum necessary income.
- Strong ties to home country with a clear purpose of visit

**No dependents can be included in this application.**

# Timeline:

The processing time for a Super Visa application depends on several factors, such as the processing center the completeness of the application etc. The typical timeline for an application depends on the readiness of invitation letter, medical examinations and insurance arrangement and the overall complexity of the case.

**Our team will assist you in gathering and verifying all the required documents.** We will also be responsible for reviewing it thoroughly to ensure accuracy and completeness and then submit the application on your behalf which could further lengthen the handling time of the application to a few months.

**We will need seven (7) working days after receiving all documents to prepare and submit your super visa application.**
